## 16/4/2019:

Pursuant to subsection 42C(2) of the *Administrative Appeals Tribunal Act 1975*, the Tribunal sets aside the decision under review and makes the following decision in substitution:

Under section 17 of the National Vocational Education and Training Regulator Act 2011 (NVR Act), the Applicant's application for renewal of registration as a Registered Training Organisation (RTO) is granted with immediate effect for a period of five (5) years from the date of this decision.

Under subsection 29(2) of the NRV Act the condition imposed on the Applicant's registration on 21 February 2014 is varied as follows:

i. For the entire period of its current registration, the Applicant must securely retain, and provide to ASQA on request, copies of all completed student assessment items for each student (per the definition in ASQA's General Direction – Retention requirements for completed student assessment items and clearly identifiable as to which student and unit/s each item related to) and copies of the master assessment tools used for each assessment, for a period of 18 months from the date on which the judgement of competence of each relevant unit of competency is made.
